

LAURENS COUNTY BOARD OF COMMISSIONERS

REGULAR MEETING

March 3, 2020 @ 5:30 P.M.

The Laurens County Board of Commissioners held their regularly scheduled meeting on Tuesday, March 3 at 5:30 p.m. Present were, Chairman Brenda Chain, Commissioners Trae Kemp, Kevin Tanner, Jimmy Rogers, and Jeff Davis, County Administrator Bryan Rogers. County Commissioner Jimmy Rogers gave the invocation and the Pledge of Allegiance.

The first item was the approval of the minutes of the February 4, 2020 regular meeting. Commissioner Trae Kemp made a motion to approve the regular meeting minutes. Commissioner Jimmy Rogers seconded the motion. All voted in favor.

The next item was to conduct a public hearing on the closing of Honey Suckle Lane. The road has been properly advertised and all owners notified of the hearing. No one was at the meeting to speak for or against the road closing. Commissioner Trae Kemp made the motion to approve the closing of Honey Suckle Lane. Commissioner Jeff Davis second the motion. All voted in favor.

The next item was to conduct a public hearing on the closing of Rocky Creek Run. The road has been properly advertised and all owners notified of the hearing. No one was at the meeting to speak for or against the road closing. Commissioner Trae Kemp made the motion to approve the closing of Rocky Creek Run. Commissioner Jeff Davis second the motion. All voted in favor.

The next item was to approve the Paint Bid. Zeigler Painting submitted a bid to paint the inside of the Commissioner's Office for \$7,519 and the breeze way for \$8,000. Commissioner Jeff Davis made the motion to approve the Paint Bid. Commissioner Kevin Tanner second the motion. All voted in favor.

The next item was to approve the new beer/wine license at Hwy 80 Hangout. They have met all requirements for on premises consumption license. Commissioner Kevin Tanner made the motion to approve the new beer/wine license at Hwy 80 Hangout. Commissioner Trae Kemp second the motion. All voted in favor.

The next item was to approve the Resolution in support of 2nd Amendment Rights. The Resolution is in support of the right to bear arms. Commissioner Jeff Davis made the motion to approve the resolution. Commissioner Trae Kemp second the motion. All voted in favor.

The next item was to approve the FY 2019 Audited Financial Statements. The audit has been completed and the County received a clean audit report. Commissioner Kevin Tanner made the motion to approve the FY 2019 Audited Financial Statements. Commissioner Trae Kemp second the motion. All voted in favor.

OTHER BUSINESS:

County Administrator Bryan Rogers asked that the County continue being the fiscal agent for Family Connection. They are current on their revenues and expenditures. We have been doing this for several years. Commissioner Trae Kemp made the motion to fund Family Connection. Commissioner Jimmy Rogers second the motion. All voted in favor.

The Sheriff's Department asked to surplus a 2014 Dodge Charger VIN#2C3CDXAT4EH191268. Commissioner Kevin Tanner made the motion to approve the surplus. Commissioner Trae Kemp second the motion. All voted in favor.
